OBJECTIVES and COURSE DESCRIPTION

The objectives of this graduate level seminar are to develop (1) an ability to recognize and work with concepts that are key to current feminist debates and research in the field of law (2) a familiarity with the main strands of literature in the field, and (3) an ability to assess the conceptual and methodological underpinnings of various types of feminist work on law. The seminar aims to expose students to diverse approaches and strategies, as well as diverse subject areas.

In 2006-07 the seminar addresses reaction and resistance to feminism, law and social change; the role of the state in social change; and women's oppression under neo-liberalism.

COURSE STRUCTURE and GRADING STRUCTURE

Key readings for the first several weeks will be assigned but students will also take responsibility for identifying relevant readings and leading sessions. The structure of the seminar will be an introduction of the week's themes by the instructor, guest speaker, or students, followed by discussions based on the readings (participation marks 15%). In order for the seminar discussion to work, each participant in the seminar is required to read the assigned materials each week. If you are unable to do so due to extenuating circumstances, please let the instructor know in advance and provide a written summary of the readings at the next class. Students are expected to demonstrate their use of resources for feminist research on law, and their appreciation of the themes of the seminar, by producing a proposal and annotated bibliography (25%) and an indepth research paper (60%) (30 double-spaced pages). This paper can be related to the topic of the student's thesis and the seminar will be adapted to meet the topic needs of students wherever possible.
