





Did you know that approximately 70% of all links in citations published between 1999 and 2011 no longer point to the same material? To prevent this "link rot" the Harvard Law School Library developed the Perma.cc system to archive cited online content and generate a permanent link to the archived record of the page.

Bora Laskin Law Library has established an institutional Perma.cc account so that faculty can create unlimited permanent URLs of the online resources they are citing.
